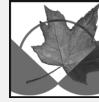

## INSTRUCTIONS TO TRANSFER PUBLICLY LISTED SECURITIES TO THE CANADIAN CENTRE FOR POLICY ALTERNATIVES (CCPA)

Thank you for your interest in donating a gift of securities to the CCPA. Under current tax regulations, your donation of publicly traded securities is exempt from capital gains tax only when you transfer the securities in-kind to the CCPA.

The CCPA accepts all publicly traded securities. A charitable tax receipt will be issued and will be based on the fair market value of the shares, determined by the closing day price of the shares the day it arrives in our brokerage account. The CCPA's policy is to sell the securities as soon as possible. In cases where the securities are sold on the date they are received, the fair market value will be the proceeds of the sale before commissions or fees.

### Electronic Transfer — Canadian and U.S. Securities

1. To facilitate the transfer, please initiate the donation with your broker and forward a completed and signed copy of this form to your Investment Advisor/brokerage institution. Your Investment Advisor/brokerage institution will arrange for the electronic transfer of shares to the CCPA's broker.
